Enrollment & Registration Procedures

Required Forms:

In order to participate in any Serious Fun program, you (the child's legal parent or guardian) must submit hard copies of completed and signed registration forms (4 pages) to the Serious Fun office by mail or in person. These forms only need to be completed and submitted once; once these forms are on file with Serious Fun, you will be able to enroll your child in any future Serious Fun program by submitting tuition payment. Payment Procedure:

The Serious Fun Lights-on! Drop-in Afterschool program tuition is \$15 per day or all 4 days for \$50. Payment may be made by cash, check or money order made out to **Serious Fun, LLC** or by credit card using our online registration service at www.seriousfuncllc.com. You do not need to have a PayPal account to use this service: you will be asked to provide your credit card information.

Enrollment Policies

Your child's enrollment in the Serious Fun Lights-on! Drop-in Afterschool program is dependent on the numbers of regular participants and your child's adherence to the behavior contract.

Other:

- Programs in which the minimum enrollment has not been reached may be cancelled
- Returned checks will incur a \$35.00 over draft fee

If I reach **Strike Three!**, I understand that I will be asked to leave with no refund. I also understand that I will not be welcome to come back without a meeting with the staff and a parent or guardian.
